Half-life data

The reactivity of an azo initiator is usually given by its half-life (t1/2) at various temperatures. For Perkadox® AIBN in chlorobenzene half-life at other temperatures can be calculated by using the equations and constants mentioned below:

1 hr	at 82°C (180°F)
10 hr	at 64°C (147°F)

Thermal stability

Azo initiators are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

Storage

Due to the relatively unstable nature of azo initiators a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (Ts max.) for each azo initiator.

Ts Max.	25°C (77°F)
Note	When stored under the recommended storage conditions, Perkadox® AIBN will remain within the Nouryon specifications for a period of at least 3 months after delivery.

Packaging and transport

The standard packaging is a cardboard box for 3 x 10 kg initiator. Both packaging and transport meet the international regulations. For the availability of other packed quantities contact your Nouryon representative. Perkadox® AIBN is classified as self-reactive solid type C; temperature controlled; Division 4. 1; UN 3234.

Safety and handling

Keep containers tightly closed. Store and handle Perkadox® AIBN in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e. g. amines), acids, alkalis and heavy metal compounds (e. g. accelerators, driers and metal soaps). Please refer to the Safety Data Sheet (SDS) for further information on the safe storage, use and handling of Perkadox® AIBN.
