


Perkadox GB-45CM

Perkadox® GB-45CM is a free-flowing 45% peroxide formulation on a phthalate-free carrier for curing unsaturated polyester resins and (meth)acrylic resins at ambient and elevated temperatures. Provides excellent solubility in standard thermoset curing applications.

Applications

Perkadox® GB-45CM is a free flowing, granular powder containing up to 45% dibenzoyl peroxide. Perkadox® GB-45CM is used for the curing of unsaturated polyester and (meth)acrylic resins at ambient and elevated temperature. At temperatures up to 80°C, Perkadox® GB-45CM should be used in combination with an aromatic tertiary amine accelerator. Above 80°C the use of an accelerator is not required. Perkadox® GB-45CM dissolves clearly in the resin system and is therefore very suitable for the production of cured parts with acrylic resins when a high degree of transparency is required.

Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the
	Transport of Dangerous Goods, Manual of Tests and Criteria – United Nations,
	New York and Geneva).

Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (Ts max.) for each organic peroxide product.

Note	When stored under these recommended storage conditions, Perkadox® GB-
	45CM will remain within the Nouryon specifications for a period of at least 12
	months after delivery.

Packaging and transport

The standard packaging is a non-returnable cardboard box for 25 kg net. Both packaging and transport meet the international regulations. For the availability of other packed quantities consult your Nouryon representative. Perkadox® GB-45CM is classified as Organic peroxide type D, solid; Division 5. 2; UN 3106.

Safety and handling

Keep containers tightly closed. Store and handle Perkadox® GB-45CM in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e. g. amines), acids, alkalis and heavy metal compounds (e. g. accelerators, driers and metal soaps). Please refer to the Safety Data Sheet (SDS) for further information on the safe storage, use and handling of Perkadox® GB-45CM.
